BURN PERMIT

PLEASE READ THE FOLLOWING TERMS, CONDITIONS AND RESTRICTIONS BEFORE COMPLETING THIS APPLICATION

Definitions: "You" and "your" mean the property owner or responsible party to whom the permit is issued. "Fire Department" means the North-West Fire Protection District.

The permit you are applying for is required and regulated by the Fire Code of the town or the county (if not located within a town) where the burn will occur. The Fire Department is expressly authorized and required by Colorado law to enforce the Fire Code. Failure to comply with the following terms, conditions and restrictions may result in forfeiture of this permit, citation under the Fire Code, fines, and/or other legal action.

Terms, Conditions and Restrictions:

- The application fee for this permit is \$10.00.
- This permit is valid through December 31 of the calendar year in which it is issued; **however**, be advised that you are required to comply with the requirements on all of your permits (District and state), including any limitations on dates or times for burning.
- You **must** Call **North-West Fire Protection District Telephone 719-836-2609** **each day** before ignition. Please leave the date of your burn, permit number and address. You can check on current fire restrictions by calling **719-836-4160** to determine whether burning is allowed that day. The recording will state District 4 is **OPEN** (burning is allowed) or **CLOSED** (no burning allowed).
- Materials may be ignited only between 10:00 am and 2:00 pm. "Ignited" means both starting a fire and adding more material to an existing fire. All fires must be completely extinguished by sunset. Camp fires are not subject to the above listed times.
- The burn must take place at an appropriate site or be contained in a steel barrel with a screen cover. The burn must be located **at least 50 feet away** from any structure or combustible material, and steps must be taken to prevent the fire from spreading within 50 feet of any structure or combustible material.
- Burns are restricted to a single location on a property. Multiple burn sites are expressly prohibited.
- Burns **must be attended at all times** by a competent, responsible individual until the burn is completely extinguished and cooled. An adequate water supply, fire extinguisher, and proper firefighting tools (rakes and shovels) must be immediately available at the burn location.
- Burning is **prohibited** for:
 - Trash, refuse, or waste products
 - Hazardous or toxic materials
 - Food waste, tires, plastics, or metal
 - Tree stumps, unless cut into fireplace-sized pieces
 - Wood residue, including bark, sawdust, chips, and shavings
 - Treated wood and treated or untreated construction debris
- A maximum of one (1) cubic yard of material may be burned at one time. Any burn larger than (1) cubic yard requires a special use permit issued by the North-West Fire Protection District.
- Ample access to the burn location for Fire Department Emergency Vehicles must be maintained at all times.
- The fire code official may order you, another responsible person, or the Fire Department to extinguish the fire if, in the fire code official's opinion, the fire creates or adds to a hazardous or objectionable situation.

- The Fire Department may suspend this permit if a Fire Department or county-wide ban on burning is issued or when in the Fire Chief's opinion **conditions are too dry or windy to safely control such burn. This means ABSOLUTELY NO BURNING.** Call 719-836-4160 if you have questions regarding current fire conditions.
- You are **solely** responsible for the proper management of the burn and for any injury or damage that may result to you or your property, or to the person or property of a third person.
- By issuing this permit, the Fire Department, and its directors, officers, employees, volunteers and agents, do not assume any responsibility, and shall have no liability whatsoever, for damage or injury to you or your property, or the person or property of a third person.
- This permit is for compliance with fire safety and control alone, and is not a permit to violate any existing state or local laws, rules, regulations, or ordinances regarding fire, zoning, building, or air quality and pollution standards. **You are responsible for obtaining any additional permits and/or clearances from any appropriate local or state agency or other official prior to beginning the burn.**
- **This permit is not transferable.** If there is a change in occupancy, operation, tenancy, or ownership, a new permit must be applied for and issued.
- You and your employees, volunteers, and agents shall abide by the terms, conditions, and restrictions of this permit. Any violation of this permit shall render this permit void, and may result in citation under the Fire Code, fines, and/or other legal action.
- In any dispute arising from or relating to this permit, the prevailing party shall be awarded its reasonable attorneys' fees, costs and expenses, including attorneys' fees, costs and expenses incurred in collecting upon any judgment, order or award.
- This permit shall be available at the burn location and must be shown upon the request of an appropriate official. All open burning operations shall be subject to inspection by the Fire Department.
