APRIL 18, 2019

ADMINISTRATIVE Agenda: Chief Olme distributed for the Board's review and approval a proposed agenda for the special meeting. Following review and discussion,

upon motion duly made by Director Nourse, seconded by Director Zingler and, upon vote, unanimously carried, the agenda was approved, as amended to include additional items from Chief Olme under Other Business.

Disclosure of Potential Conflicts of Interest: Chairman Crago inquired whether there were any conflicts to disclose by Board members present, which have not already been adequately disclosed. There were no potential conflicts to disclose by Board members present.

<u>Community Comments:</u> There were no members of the public in attendance.

<u>Directors' Items</u>: There were no Directors' Items brought before the Board.

2019 Lease Payment to Tax-Exempt Leasing: Ms. Tinney reported on discussions with Tax-Exempt Leasing and Chief Olme following the Board's April 10, 2019 regular meeting, and Ms. Adler reviewed the status of the ongoing investigation by the fraud division at 1st Bank. Following discussion, upon motion duly made by Director Zingler, seconded by Director Nourse and, upon vote, unanimously carried, the Board approved the 2019 lease payment to Tax-Exempt Leasing.

COMMUNITY MATTERS

OTHER BUSINESS

November 2018 Election Expense: Chief Olme presented to the Board an invoice from Park County in the amount of \$5,167.50 for conducting the November 2018 coordinated election. Following review and discussion, upon motion duly made by Director Castellano, seconded by Director Nourse and, upon vote, unanimously carried, the Board approved payment of the invoice from Park County in the amount of \$5,167.50 for conducting the November 2018 coordinated election.

Command Vehicle Purchase. Chief Olme reported that the District has the opportunity to purchase a vehicle from Stevinson Chevrolet command approximately \$40,000, which is included in the 2019 Budget. Should the Board approve the purchase, Chief Olme can make arrangements to pick up the Following discussion, upon vehicle next week. motion duly made by Director Zingler, seconded by Director Nourse and, upon vote, unanimously carried, the Board approved the purchase of the command vehicle for approximately \$40,000.

Wildland Season Staffing. Chief Olme requested the addition of three, part-time personnel for the wildland season from May 1st through October Chief Olme further requested that District provide health insurance for individuals at a total cost of approximately \$1,600 per month. Chief Olme expects that the cost of health insurance for these part-time the employees will be covered by wildland Following review response revenue. discussion, upon motion duly made by Director Castellano, seconded by Director Nourse and, upon vote, unanimously carried, the Board approved the addition of three part-time personnel for the wildland season from May 1st through October 1st, including the provision of health insurance to the newly hired personnel.

There being no further business to come before the Board, upon motion duly made by Director Zingler, seconded by Director Castellano and, upon vote, unanimously carried, the meeting was adjourned at 6:16 P.M.
